1. Bankruptcy - Tumunun nonomun aramas me sopai seni osukosukan ar niwinimang. (ei sakkun napanap a mumuta non annuk pwe emon aramas are sopai mei tongeni awora tungor an esap mo awesi an kewe niwinimang nupwen a tori fansoun kamotiw ren popun epwe afat me non kapung).
2. Consumer protection or products liability - tumunun an aramas pung fanasengesin pisek ir mei kamo seni emon aramas are eu sopai nge mei ngaw.
3. Conservatorship or guardianship of the person or property - Tumunun emon aramas are pisekin nupwen epwe kefinita me me non imwen kapung.
4. Criminal proceedings - aninis won angangen an emon aramas kapung.
5. Estate planning - kokotun ren tumunun me inetin pisekin emon aramas murin an mano.
6. Family Law - adoption, child support, custody, divorce- aninis won mumun semirit, achawar ren tumunun emon semirit, kefinitan tumunun emon semirit me non imwen kapung, mufesenin eu pupunu.
7. Malpractice - aninis won kapung ren pekin wis are angang ese pung napanapan.
8. Private insurance issues - aninis ren kokotun ekkewe sakopaten insurance an aramas.
9. Property disputes - aninis won atawen osukosuken pisekin aramas.
10. Tax issues - aninis won kokotun me porausen takises.
11. Tort defense - aninis non peking kapungun eu fofor mei esenipato feiengawen me osupwangen nanomun emon aramas pokiten mwaken me tumunungaw.
12. Workers compensation or ERISA - Kaworen niwinin chon angang nupwen ar etiwano angang pokiten fiengaw are semwen mei fis ngenir me non nenien ar angang

Menapen Poraus: Uruwo me Auchean Angang

Ewe Hawaii Disability Rights Center (HDRC) iei ei neni a kefinita pwe epwe wisen Tumunu pwan Apochokuna pekin annuk me ekkewe pung a kawor fan asengesin aramas mei wor terir, apwan kefinita pwe eu nenien awora aninis ngeni aramas mei wor terin inisir, Client Assistance Program (CAP). HDRC a poputa ren pekin chok aninis non 1977 ren an epwe tutumunu pwan apochokuna an aramas mei wor terir kewe pung fan nurun annuk.

A wor fisu kinikin non annukun ewe muunap a awora ngeni HDRC ekkewe pochokun ren an epwe wisen tumunu pwan apochokuna ekkewe annuk mei kawor fan iten ekewe aramas mei wor terin inisir, umwes me pwan ekkoch tufichingawen ter.

HDRC a wisen angang fan iten aramas mei wor terin inisir. A wor terin emon aramas ika a nom non eu ekkei sakkun napanap are kinikinin ter: emon ese tongeni pusin anganga are tumunu inisin, ese tongeni mokutukut fetan won pusin ii chok, ese tongeni akanemon chok, ese tongeni pusin awora an tufich, ese tongeni kaeo, ese sinei wenen an fetan, ese pwan togeni rongorong, weweiti are fat an kapas.

Ekkewe pekin aninis a kawor meren HDRC a pachenong **Aninis me Tumun** - ewe pung an epwe tongeni angei ekkewe sakopaten aninis me tumun non neeni mei nukunukoch me kinamwe; neeni esap uwor tumunungaw me turunufas; epwe kawor ngeni ekkewe napanap fan pungun annuk, ren mutate mefian, kapas mei monomon won winikappan, nonom non kinamwe fan pungun annuk. **Re-winipos** - epwe mecheres ngeni ekkewe neenien aramas an muun an epwe aea; epwe tufichin mokutukut fetan; ewe fiti uutut; epwe tongeni chooni ekkewe mwich rekan awora pungun ew kapung; (jury); epwe tongeni awora noun toropwen etipeew; epwe fofonu pwan amomono, epwe pwan tongeni re-winiposen eu neni. **Pekin Kaeo** - ewe pung ren an epwe kawor ngeni ekkewe sakkun kaeo me anninis epwe weneiti term inisin we; epwe pwan tongeni nom non ekkewe wesewesan rumwen sukun are kaeo (classroom); esap fis ngeni arrest mwan chok, asosono are fen

pwan tou seni sukun ika ese wor popun. **Pekin Angang** - esapw uwor nifinifin nupwan kefinin chon angang, ekkewe pung meinisin ren pekin chon angang epwe kawor ngeni; ewe pung ren an epwe angei anninis ika mei wor an osukosuk seni ewe pekin VR. **Prokram me angangen aninis** - ewe pung ren an epwe kawor ngeni emon ekkewe prokram me angangen aninis; esap fis nifinifin ngeni emon ren an epwe angei ekkewe sakopaten angangen aninis ika mei weneiti fan pungun annuk; ren pekin Mwesin, Medicaid are insurance, SS/SSDI, sein neman me won sat, pwan ekkoch pekin aninis ren aramas mei wor terir ese pwan mak non ei toropwe.

Ikkei ekkoch napanapen angang HDRC a pwan achocho ne fofori:

1. **Otura me Kuta** - ra achocho ne kuta pwan atoura poraus fanasengesin ekkewe mei ter ese tour ngenir me unus ngenir ekkewe aninis (me nein ekkewe tetenin aramas, einang, me mwicheichen fonu). Ra pwan chooni ekkewe mwichen kousen me sakopaten mwich mei kawor fan asengesing aramas mei ter.
2. **Poraus fiti tungor** - ra achocho ne poporaus fanasengesin mei ter pwan achocho ne tungor aninis seni ekkoch putai ren ar repwe awora aninis nupwen HDRC ese tongeni awora ekkoch ekkewe tungor an mei ter.
3. **Asukuna me Pomweni** - ra awora pekin kaeo me aiti pomwen angang ngeni mei ter, famini, chon sop, chon angangen pekin annuk , me chon awora ekkewe pekin aninis.
4. **An Emon Mochen** - ra fokkun apochokuna pwan achcho ar repwe tongeni anisi me atawei an emon mei ter osukosuk pwan kuta me awora ekkewe sakopaten pekin pisek me aninis epwe tongeni anisi are atufichi nonomun emon mei ter non fansoun mochomoch are non fansoun nangatatam.

Met sakkun ter epwe wor ren emon:

1. Emon aramas epwe wesewesen wor **terin** inisin usun afen awewetiwi non nouch CAP are non eu ach kewe P&A prokram; pwan
2. Emon aramas epwe wesewesen wor ren ewe **aukukun terin inis** usun afen afat non CAP, P&A, me WIPA prokram; pwan
3. An emon we **tufichingaw** a feito seni terin inisin we; pwan
4. An emon we tufiehingaw a nom non an HDRC kewe **tetenin aninis**.
